4. Vendor agrees to provide own tables, chairs, tents and may need to provide own power with an approved generator should shore power be unavailable.
5. The Vendor shall pay to SI Bidwell Rancho or the use of such space the sum of \$150 payable in advance to SI Bidwell Rancho
6. The Vendor shall provide evidence of Insurance to SI Bidwell Rancho
7. SI Bidwell Rancho reserves the right to permit only those products described in the contract and to prohibit any items, conduct, printed matter, advertising, souvenirs, and emblems presented by any Vendor and or their employees upon the premises that may negatively affect the event. SI Bidwell Rancho reserves the right to require removal of any items that are not described above or do not meet the commercial limitations addressed above.
8. The Vendor agrees that he/she has read this agreement, the conditions, rules and regulations, and understands that they apply, unless amended by mutual consent in writing by the Vendor and SI Bidwell Rancho.
